General Meeting Minutes

The meeting was called to order at 7:30pm by President Doyle Ridgeway. All Board members present except Johnny Ray Carter.

The Secretary Patrick Neenan read the minutes of the May 15<sup>th</sup>, 2021 annual meeting. A motion was made to accept the minutes by Odie Carter and seconded by Jason Wright. Motion passed.

The Treasurer Tom Laflam read the yearly financial report. A motion was made to accept by Odie Carter and seconded by MG Ridgeway. Motion passed.

The President Doyle Ridgeway explained the dues for this year would be \$2250.00. ½ paying members will pay \$1125.00. Full paying members if paid by March 15<sup>th</sup> will get a 50% discount and pay \$1125.00. If paid after March 15<sup>th</sup> the dues will be \$2250.00. This is based on an estimate of how much the lease went up last year, if lease goes up more than projected, the Board will have to charge the members additionally.

There was discussion on roads, members running the grader, lime rock and food plots. No motions were made.

Wayne Morrow and Mg Ridgeway discussed a benefit for Round man on June 4<sup>th</sup>, 2022.

There was discussion on doe tags and getting them this year. Marvin Hassel made a motion if we got them to have the hunter who killed the doe report his tag number to the board. MG Ridgeway seconded this. Motion passed pending acquisition of the doe tags.

The Treasurer Tom Laflam read a letter submitted to the Board proposing that handicapped/ disabled persons of any age pay half dues of \$550 per year. Proof of disability would be required. Nobody seconded this and the motion died on the floor.

President Doyle Ridgeway opened the floor for nominations for Aaron Dawsons' Director position. Jason Wright nominated Aaron Dawson with Lyle Parrot seconding. A motion to cease nominations was made by Robert Rewis and seconded by Mg Ridgeway. Motion passed.

President Doyle Ridgeway opened the floor for nominations for Patrick Neenans' Secretary position. Robert Rewis nominated Patrick Neenan with Jason Wright seconding. A motion to cease nominations was made by Odie Carter and seconded by Mg Ridgeway. Motion passed.

President Doyle Ridgeway opened the floor for nominations for Doyle Ridgeways' Presidents position. Charlie Watson nominated David Sanders with Robert Rewis Jr. seconding. Lebo Mathis nominated Doyle Ridgeway with Mg Ridgeway seconding. A motion to cease was made by Odie Carter and seconded by Jason Wright. This will go on the May ballot.

A motion to adjourn was made by Mg Ridgeway and seconded by Jason Wright.

Meeting adjourned at 8:18pm.
